To make paying tuition easier, we have set up an AUTOMATIC PAYMENT PROGRAM using your credit card or debit card. It costs nothing extra and is required: We accept Visa/Master Card/Discover

_____ I **DO** authorize to have my payment automatically charged to my credit card each month.

A statement will be provided each month via e-mail. Any curriculum changes will be reflected in the monthly price. If funds are unavailable on the 1st of the month credit card will be charged on the next business day with an unavailable funds fee of \$25.

Section E ~ Client Agreement *PLEASE INITIAL BELOW*

_____ **Enrollment Fee**~ I understand that the enrollment fee paid upon registration is Non-Refundable.

_____ **Monthly Installments** ~ I agree to comply with the payment method I have chosen to pay for tuition, tights, & costumes, for this season, understand that if I do not follow the policy fees will be incurred and will not be negotiated, and also that classes and enrollment are for an entire season and not a month to month.

_____ **Costumes and Tights**~ There is a \$55 Costume Deposit charged in November per class. If my child decides to drop from the class this deposit will not be refunded. Costume Balances are charged in January. Costume Balances range from \$55-\$65. I understand that if my child decides not to participate in the show prior to January 1st, I will not be liable for the Costume Balance. If I choose not to participate in the show after January 1st, still must pay for the Costume Balance. Each costume requires show tights that are not included in the costume price. They range from \$12-\$16 depending on size and style. Tights must be purchased through NYCPAC to ensure every student has the same color and style.

_____ **Under Enrollment** ~ Any classes with less than 6 students registered will be canceled or merged with another class.

_____ **Instructors** ~ I am aware that I am registering for a specific class at NYCPAC and not with a given instructor. NYCPAC reserves the right to replace an instructor at anytime within the season as best suited for the school and the students.

_____ **Withdrawal** ~ I understand that I am registering for a 12 month contract, and will be held responsible for the entire 12 months of payments. If I decide to withdrawal my child/children from any classes, I will still be liable for continuation of payment to NYCPAC. By signing this agreement, I acknowledge and agree to comply with the policy set by NYCPAC. I also understand that tuition is based on an entire season, and is divided into 12 monthly payments for my convenience. If I decide to withdrawal and refuse payment to NYCPAC, then NYCPAC will charge the remaining balance owed in full on the credit card provided on file. Installments will not be credited or refunded even if classes have not been attended.

Section F ~ Liability

_____ I, the undersigned agree to provide medical insurance for my child/children and will not hold New York City Performing Arts Centre, Inc. or its agents or employees liable in the event of any accident or injury. If I am not reached in an emergency I give my permission to the staff to render aid or act on my behalf to obtain emergency medical treatment for my child/children for any injury that may occur while attending the studio.
